A. JUVENILE JUSTICE:

Courts/Peer Court: Judge Candace S. Heidelberger not present.

Chuck Coovert reported the last meeting regarding starting Peer Court. Discussion whether Peer Court should be started again. As of this date, it is still pending.

Probation/Juvenile Hall:

Juvenile Hall: Total population: 4 youth.

Out-of-County contract: 2 youth (1 male, 1 female).

Local youth: 2 youth (1 male, 1 female)

Update on Tuolumne County Juvenile Hall that they are delayed in opening until late February.

Chief Ertola gave an update on the Transitional Age Youth (TAY) Program. BSCC application submitted and we should receive approval within 30 days. Hopefully within the next few weeks, Juvenile Hall should be able to get the TAY program underway.

Chief reported Juvenile referral statistics: Year 2007 – 758, 2008 - 818, 2016 - 241, Chief reported this is due to Probation; programming, juvenile crime is down, NEO (Contract with Probation– Low risk youth offenders' pro-social activities) and WRAP Services.

Probation: Probation construction update – February 13 is the date for the Public Defender's office to move in.

602 Youth Mentoring: No report.

602 Youth Foster Parent Recruitment: Special Presentation AB 403 (Foster Youth: Continuum of Care Reform) by Mike Dent and Nick Ready from CPS. Nick Ready explained AB 403, Legislation to preserve and strengthen a child's family ties whenever possible. How it is impacting Nevada County group homes, foster care and how it will impose training requirements on foster parents. Nevada County is offering the training to meet the needs of the foster parents by conducting the training on weekends and in their homes. The feedback has been positive.
